The FY 2025—2026 budget includes cost-of-living considerations only. Any wage adjustments are contingent upon budget feasibility at the midpoint of the fiscal year and may be considered only if expenditures are on target or under budget. Due to a Lack of cooperative coordination, the CPA has not presented current financials to Council; therefore, the Council does not have verified information regarding the City's present budgetary position.

For the record, the Court Clerk duties have been and will continue to be performed by the Water Billing Clerk & Clerk/Treasurer extra duties. The Court Clerk function is not, and has never been, a separately compensated or individually designated position. Court Clerk responsibilities are included as part of the assigned duties of existing office staff.


